## **2011 Property Tax Notices**

Tax notices are included with this mailing. A **15% discount** applies to all payments **received by May 31<sup>st</sup>**. As Jessie will be away from the Village Office enjoying the sights in Paris from May 28 to June 3<sup>rd</sup>, please bring your tax payments to her before then or mail them postmarked by May 31<sup>st</sup>. The postmark is the deciding factor to be eligible for the discount.

#### Village Clean-up Day – May Long Week-end

The Village Office has been given several pictures depicting some unsightly yards throughout the village. The long weekend in May is marked as "Village Cleanup Day". Please do your part and help make our community a more pleasant place to be. The village will be bringing in red bins to accommodate removal of debris from your yards and to collect all your household debris. Please do not deposit construction materials or furniture in these bins. Tree branches can be hauled to the landfill.

To celebrate the 'cleanup' of our village – Hot dogs will be served at the Maintenance Building from 9 - 12 on Saturday, May  $21^{st}$ . Plan to do your part and then come and join your neighbours for a coffee break or lunch – whatever fits into your schedule.

#### **Parking in Alleys and Green Spaces**

It has been identified that we have some parking of trailers & vehicles in our alleys. Alleys are <u>not</u> intended for parking and these items <u>must be</u> relocated to private property. Parking on our green spaces is also <u>not</u> permitted. Volunteers have worked hard to make our community a pleasant place to enjoy open areas. Encumbering the park areas with trailers and fishing huts is not acceptable. Please remember that any items located on municipal lands may be removed at the owner's expense.

#### **Space for Tree Nursery**

#### Fire Fighting Fees – Are You Covered?

A reminder to everyone that fire fighting fees from our Fire Department in Dundurn are \$750 per hour should they be called. Please check your insurance policy to ensure you have coverage to cover these charges if needed.

#### EMO

The Resort Village of Shields has an Emergency Measures Organization (EMO) that prepares and operationalizes activities that may be required in the event of accident, war, forces of nature, or any other situation that may present harm to the safety or welfare of people, or widespread damage to property. Our EMO is governed by the provincial Emergency Planning Act 1989, and the Resort Village of Shields bylaw No. 2/04. Since 2004, our Coordinator has been Evelyn Campbell. Evelyn and her hard working group of local residents have been very involved with Cabin Watch over many years. The evolution of Cabin Watch into EMO is no small feat. The Village is very grateful for the years of work and watchfulness of Evelyn and EMO committee volunteers. Evelyn is now passing the reins for EMO to Deb Heidt, who will serve as EMO Coordinator, and Karen Powell, who will serve as EMO Assistant Coordinator. Local residents will hear much more in the coming weeks as we prepare the Shields inventory of residents, their emergency training and skills, and equipment that may be available as the need arises. Another dozen Shields residents have already come on board to provide much of the legwork that will be done.
