The Dundurn and Area Waste Water Utility is currently engaged in the resolution of the waste water dump site in the Resort Village of Shields. The Board is diligently negotiating a solution with its partners, engineers, and government regulators to restore this essential component. Progress has now entered a phase whereby decisions will soon be forthcoming. Representation to the Board has been assisted by a committee in addition to the Board Chair to bring this action to a conclusion.

The resort villages of Thode and Shields are cooperating in an arrangement whereby we will employ a full time maintenance foreman under which operational aspects of the two villages will be coordinated. The intention of this collaboration is to streamline the maintenance activity within operational and capital requirements of the villages. This will not affect the seasonal and/or student staff requirements of either village, however management of staffing requirements will be coordinated under the new position.

We have new construction beginning in the South Subdivision, interest in home building continues in and around our village.


Shields Celebrates Canada "Our Multicultural Heritage"

If you see an offence you are encouraged to report it to the RCMP with the time, date, location, licence plate information (if applicable), and as many other details as you can offer. In addition, the Village has recently purchased a speed sign (jointly with the RV of Thode). This sign will have the speed limit posted, as well as flash the current speed to the drivers on the road (much like the ones in construction zones). This piece of equipment will have a program, which will collect data for the Village and RCMP use.

If a situation results where municipal staff cannot determine the location of your curb stop, you will be invoiced for the time spent locating the stop. Please ensure that you are prepared for the winter and curb stops are protected and will be free of snow, ice and debris and readily available for the Town Maintenance to shut off at any time of the year if needed.

Critter Comforts

Are you inadvertently or unknowingly providing a habitat for some of Mother Natures' "Cute Critters"? Living in a rural area, such as we do here in our Village, we often see or encounter various forms of wildlife. In as much as we enjoy observing and learning about these "critters" we do not want to turn our homes or outbuildings into their "Winter Resorts"!

Here are just a few helpful hints, to try and ensure that they and we maintain our natural habitats during the cooler months. For raccoons or any wild animal, denying them access to attractants, which can be food or shelter, is the best way to prevent problems!

- 1. Keep all garbage and composters in secure containers.
- 2. Sandboxes should be covered, prevents raccoons especially, from using it as their bathroom!
- 3. Do not leave pet food or garbage outdoors.
- 4. Clean up acorns or fruit that falls from trees, as well as any branches or other plant materials that may be lying around, on or near your property. This is perfect material for mice, and other vermin to use as "housing".
- 5. Block even the "smallest" access to attics, sheds, chimneys, or other potential dens.
- 6. Remove overhanging branches to restrict access to rooftops.
- 7. If you have ever had a raccoon take up residence in your home, you should take steps to disinfect or otherwise remove their odor, as this lingers and attracts other raccoons to visit.

Let's keep our homes for ourselves and let the "critters" house themselves as Nature intended.
