

## Mayor's Message

This Spring message is clouded by the event of earlier this month as we share our grief and heartbreak with the extended family of the Humboldt Broncos organization. Certainly, the priorities of our lives are brought into focus by such tragic events, shared by people and communities throughout the World. On behalf of our community, I have sent a message of condolence to the Humboldt community.

The recent event in Toronto has also brought forward thoughts of how lives can be instantly affected by seemingly senseless acts. To those folks we also share in our thoughts and prayers.

After the Spring of 2018 "stall mode", the forces of Mother Nature seem to reveal that we can experience the clean up stage within our village. As a point of interest we are reminded that the ice left Blackstrap Lake on April 13 of 2017.

Our Council has been active in negotiations within our Region regarding roads, services, bylaw enforcement, and positions regarding planning for the future.

As many are aware, the Blackstrap Resort Villages have found strength in our joint infrastructure and maintenance efforts. This, in addition to the Councils of our communities sharing in common perspectives of providing effective leadership to our residents and property owners as we move forward with the growth of our respective villages. On April 12 we met with the RM of Dundum Council in order to establish an access road maintenance agreement. Formulation of a pending agreement was on the agenda at the RV of Shields regular Council meeting and was sent to the RM Council for their meeting on May 8.

We are pleased to share in the excitement of new homes being built in Shields. Indeed, we welcome those who are new to our community. From last Fall we have greeted some 14 newcomers to our Resort Village.

As with every Spring in our community, there is excitement about the opening of our golf course. The staff and volunteers have uncovered the greens and prepared the course for the enjoyment of residents and avid golfers. We wish our course and golf committee much success for the 2018 season.

Council approved a number of "new and improved" services to our community in our 2018 budget. The plans for dust control and road surface enhancement have taken precedence.

Of critical importance is the seasonal irrigation system; the pumping system is being revamped and well as potential correction of the intake system. It is of concern that our consumption of lake water through the irrigation system and power bills have added a significant cost to our operations - PLEASE PLAN TO CONSERVE IRRIGATION WATER THIS SUMMER.

As always, our Council meetings are open to the community. We encourage all to enjoy the sights and sounds of Spring in and around our community. The village is humming with yard work and street clean up - enjoy Spring 2018. Please plan to attend our annual gathering on May 19 - Saturday morning. Announcements later in this letter and on the message board.




## Hall Committee

The course officially opened on Saturday, April 28 which is the same date as last year! Rates for 2018 season have not changed and remain the same as 2017 – Season Pass

## Use of Irrigation Water and Water Conservation

With Spring on the way, and thoughts turning to getting yards ready for summer, we want to remind you to ensure all taps connected to the seasonal irrigation are turned off. This will assist Operations staff as they complete the annual process of turning on the seasonal water system. With the late thaw this year, it is expected activities will be delayed for a while yet.

We ask for your assistance in using irrigation water wisely because water conservation is a good thing to do and it helps lower the amount all residents pay for irrigation water. You do not pay directly for seasonal water, but it is part of your taxes and the power to operate the seasonal system is expensive.

#### TIPS for Watering

- Maintain your irrigation system so it operates properly and without leaks.
- Sprinklers should water landscape areas and not spray buildings, fences, or non –landscaped areas.
- Watering should not be done during the heat of the day to reduce evaporation loss.
- Turf areas, planters, trees, and shrubs should be watered separately to meet varying water needs.
- Never turn your irrigation system on and let it run continuously for several days.
- Residents should consider watering during the week to ensure good pressure for seasonal residents on the weekends.

There are times when our average daily consumption of water for the seasonal system is 100,000 gallons. It is possible that we may need to establish a system of alternate days for watering to avoid excess pressure on the system.

## Village Administration

#### **Property Taxes**

Due to assessment appeals, the tax notices will be delayed. Target date is end of May. The 15% discount has been extended to July 31 for the 2018 tax year.

#### **Asset Management**

The Asset Management Policy has been posted to the website – shields.ca. The Village Asset listing is available upon request.

#### **Change of Address**

Please advise the Village office of your new mailing address if you are now receiving your mail at the Shields mailboxes, as the address will not be changed until notification is received from the residents.

#### Pet Owners

Just a reminder that dogs are not allowed on the golf course in the summer or winter.

Please be considerate of others and pickup after your pets! Animal feces is unsightly, unpleasant and can carry disease. In addition, failure to pick it up can result in fines. Bylaw #311 states the following:

If an animal defecates on any public or private property other than the property of its owner, the owner shall remove such defecation immediately. This applies to dogs and cats. Failure to pick up the defecation could result in the following fines:

Defecation and Litter Clean Up:

 - 1st Offense
 \$ 50.00

 - 2nd Offense
 \$100.00

 - 3rd Offense
 \$150.00

- additional non-compliance in increments of \$50.00 commencing at \$200.00

Be a responsible pet owner and help keep our village clean.

#### **Boat Docks and Lifts on the Shoreline**

It is a requirement that all docks and lifts stored on the shoreline for the winter months be tagged with owner name and contact number. Just a reminder to everyone as of May 31<sup>st</sup> all docks and lifts must be in the water or removed from the beach front/shore line area. This public reserve land is not to be used for storage in the summer, it is a privilege to be able to have our docks and lifts in the water so please everyone lets keep the beach area clean of debris.

Village management will perform a walk about of the shoreline to identify any material without identification that may be deemed abandoned and would be removed from the shoreline. If you know of any lifts or docks that have been abandoned please advise Council Member Dwayne Heidt (306-492-2218) so they can be dealt with. Thank you for your co-operation in keeping our shorelines clear of debris and help to maintain the beauty of our Village.



#### **Blue Recycling Container - Allowable Items**

- Containers please rinse and remove all caps and lids, <u>place into the bin loose do not bag or tie</u> (except for plastic bags and shredded paper – they should be tied inside a clear plastic bag)
  - o **Includes**: water bottles, soft drink cans and bottles, beer cans, milk jugs and cartons, detergent bottles, plastic bags and clean food wrap (place inside another bag and tie closed), windshield washer fluid bottles, tetra-pak boxes, tin cans, juice containers, yogurt and margarine containers
  - o Plastic containers must have the recycling arrows and a number inside, as shown below.



- Items Not Allowed: motor oil jugs, plastic toys, outdoor lawn furniture, contaminated food wrap, plastic or wire clothes hangers, hazardous chemicals, glass cups or dishes, ashtrays, window glass, auto parts and scrap metals, Styrofoam, plastic pipe, light bulbs, batteries, plastic containers without the recycling arrow and a number inside
- Paper and Cardboard please do not bag or tie
  - Includes: newspapers, magazines, catalogues, office paper, envelopes with or without windows, junk mail, cardboard, cereal boxes, tissue boxes, paper towel cores, bathroom tissue cores, paper bags, gift wrap, telephone books, hardcover books with covers and spine removed
  - Items Not Allowed: soiled tissues, napkins or paper towel, Styrofoam, waxed paper, food contaminated paper or cardboard, garbage, organics, confetti paper

#### **Public Reserve Land**

Spring has arrived and with it, we will once again have residents strolling along the shoreline. Those with cottages along the shoreline will be out surveying what needs to be done after the long winter. Others will take advantage of the nice weather to greet our neighbors and enjoy the lake's natural beauty.

For the most part, Shields has Public Reserve area between the surveyed lots and the lake. These reserves are intended to provide recreation space or public access for all residents. Most of these areas are very wide but erosion has narrowed some areas.

Shields Council, under the Saskatchewan *The Planning and Development Act*, has the responsibility to provide public shoreline access and to manage shoreline development. Some lakefront residents have requested permission from Council to undertake landscaping on the reserves. Council has entered into agreements with some property owners to locate fire pits and lawn furniture, flowerbeds, birdhouse poles, etc. in these areas. These agreements do not prohibit residents from walking through these areas and has the added benefit of adding points of interest along the way.

We ask everyone who uses the public reserves to be respectful of your neighbours who live next to them. We ask those who have property next to the lake to know where your property line is and consider your neighbours "from the back rows" when planning improvements or landscaping.

#### The Safer Communities and Neighbourhoods (SCAN) Act in Saskatchewan

On any block and in any neighbourhood, it only takes one house that is harbouring illegal activities to undermine the safety of all residents of that community and affect the property values throughout that neighbourhood. The Safer Communities and Neighbourhoods Act is intended to empower residents to take back their neighbourhoods by reporting problem residences or businesses that are habitually used for illegal activities. These activities could include drugs, prostitution, gang or criminal activities, child sexual abuse or the unlawful sale or consumption of alcohol.

### **Waste Water**

#### Why it is important?

We "live at the lake" to enjoy activities beside and on the lake, the beauty around the lake, and nature in our backyard. We are aware of our responsibility to protect Blackstrap Lake from harmful things. Each resident and the village share this responsibility.

Wastewater management is important on all properties in the village, especially those on the lakefront because of the proximity to the lake. Wastewater that escapes from holding tanks could contaminate the underground water. It could enter the lake reducing water quality and encouraging the growth of weeds and algae.

#### What have we been doing?

We have joined South Saskatchewan River Watershed Stewards (SSRWS) to assist us. Last year we worked with them to complete an inventory of the shoreline. This resulted in a "love Your Lake Report" being sent to lake front properties identifying any issues that were observed during the inventory of the shoreline. A few months ago we sent out a Waste Water survey to collect information on holding tanks and to obtain your views on the health of Blackstrap Lake.

#### **Results of the Shields Waste Water Survey**

- 115 responses from the 180 surveys sent out
  - o 41% have property on the shoreline
  - 87% have holding tanks
  - o 4% have other waste water systems
- 10% indicated regular holding tank inspections were extremely important while almost 13% indicated not at all important
- Issues identified as very important on impacting the health of Blackstrap Lake
  - Water Quality, Potential for Aquatic Invasive Species, Water Levels, Fish populations
- Overall quality of Blackstrap Lake
  - o 2% excellent, 22% good, fair 38%, poor 34%, unsure 5%
- 40% of respondents indicated an interest in learning more about how property owners can affect water quality, wildlife habitat and the overall health of Blackstrap Lake.

#### **Next Actions**

South Saskatchewan River Watershed Stewards

Compile information from similar surveys across the province to get a larger picture of how wastewater inspections are being managed. Review the survey data from Shields and will advise if there are programs to assist with tank inspections.

Shields Residents are encouraged to find out more about their system, and learn more about how they can affect water quality of their lake. If you are among the 4% of residents who identified "other" as their waste water system, it is critical you find out more and take action to ensure proper disposal of waste water. If you have never had your holding tank pumped out perhaps it is time to investigate your infrastructure - leaking tanks affect the quality of Blackstrap Lake.

Shields Council has information regarding holding tank pump outs and water consumption. Our spreadsheets indicate where there may be issues. Consideration is being given to how to address properties where there may be concerns.

#### **Shields Waste Water Facts**

- New subdivisions -gravity lines connected to waste water system
- Rest of village -holding tanks. All effluent that goes into a tank must be "held" until it is pumped out by a truck. Waste water is then hauled to village truck dump connected to waste water system
