

## BYLAW NO. 1/25

### A BYLAW TO FIX RATES TO BE CHARGED FOR THE COLLECTION AND DISPOSAL OF WASTES OR REFUSE, AND TO PROVIDE FOR TRANSFERRING OF ANY UNPAID ACCOUNTS TO THE TAX ROLL

---

COUNCIL of the Resort Village of Shields, in the Province of Saskatchewan, enacts as follows:

**1. Purpose:**

This bylaw purpose is to set rates for the collection and disposal of waste and refuse for subscribers in the Resort Village of Shields.

**2. Definitions:**

In this Bylaw, the following terms shall have the meanings ascribed below:

- (a) "Act" means The Municipalities Act, as amended or replaced from time to time;
- (b) "Administrator" means the administrator of the municipality.
- (c) "Municipality" shall mean the Resort Village of Shields.
- (d) "Subscriber" shall mean the assessed owner of a property for the purposes of taxation whom their names are on title with the municipality on the Tax Roll
- (e) "The Garbage Rates Bylaw" shall mean Bylaw no 4/23;
- (f) "The Water and Sewer Rates Bylaw" shall mean Bylaw no 3/23;
- (g) "Village" shall mean the Resort Village of Shields;

Terms used but not defined in this Bylaw shall, except where the context requires otherwise, have the same meaning as in the Act.

**3. Rates for Subscribers:**

Persons who own or occupy a premises being served with the collection, removal, or disposal of solid wastes or other refuse shall pay for such services a charge as set out below:

- a) Residential - \$29.00 per month which includes (1) one waste cart and (1) one recycle cart.
  - i. Seasonal Service (6) six months from May 1 to October 31 – off season cart rental fee of \$1.35/cart (\$2.70/month) will apply.
- b) Businesses/Commercial shall be charged as follows:
  - ii. Residential Cart -\$29.00 per month which includes (1) one waste cart and (1) one recycle cart.

Billing for collection, removal or disposal of solid waste or other refuse, shall cover a period of one month, and shall be invoiced with the regular resort village utility billing at the end of every quarter with payment due 30 days from the beginning of the next month.

**4. Penalties:**

Accounts for collection, removal or disposal of solid waste or other refuse that are unpaid after the end of the current billing period shall be considered in arrears and the penalty shall be 2% of the arrears per month (billing period) and the service may be discontinued. In the event the service is discontinued, it will not be reinstated until the account is brought to current and all penalties and arrears have been paid in full.

Any sum payable to the urban municipality for the collection, removal or disposal of solid wastes and other refuse that remains unpaid on December 31 of the year in which the sum became payable may be added to, and thereby form part of the taxes on the land and/or buildings in respect of which the collection, removal or disposal was done.

If a cart becomes damaged due to misuse or vandalism the account associated with said cart shall be charged \$135

An occupier of a residential property provided with garbage/recycling collection service who does not abide to Section 5(a) or (b) shall be subject to the following fines and may have their service cancelled.

- (a) First offence - \$20.00
- (b) Second offence - \$50.00
- (c) Third offence - Cancellation of service

Reinstatement of services will commence after receipt of a \$100 penalty.

**5. Requirements for Subscriber:**

An occupier of a residential property provided with garbage collection service must:

(a) store all garbage/recycling containers on the property to which they belong, and ensure that they do not encroach from such property, or project over any street, lane or other public place;

And

(b) place all garbage/recycling containers in accordance with the following:

(i) be placed adjacent to, but not on the travelled portion of the roadway on collection day, and so that they do not endanger vehicle or pedestrian traffic or interfere with municipal street cleaning or other equipment.

(ii) be placed for collection no earlier than 8:00 p.m. of the day before collection day and no later than 7:00 a.m. on collection day, and they must be returned to their storage location no later than 7:00 a.m. the next day.


**6. Bylaw Effect Date:**

The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee on bylaw 3/23, or January 1<sup>st</sup>, 2024, whichever is later.

**7. Repealed Bylaws:**

Bylaw No. 4/23 'Waste Disposal' and Bylaw No. 7-23 "Garbage Rates Amendment" is repealed, the date bylaw 1/25 comes into force.
