# HIGHLIGHTS OF OCTOBER 21, 2020 COUNCIL MEETING (full minutes approved at November 18, 2020 Council Meeting and posted upon approval)

#### **ROADS**

- Council will continue negotiations regarding a Road Agreement once the RM election is done.
- Village to retain ownership of grid road adjacent to Sunterra Ridge Subdivision, but will implement a Heavy Haul Route on this portion of the roadway & south memorial from the south boundary line to water treatment plant to accommodate agricultural traffic.
- Snow removal will start in the Village soon and everyone needs to ensure that vehicles, RVs etc. are not on the roads
- Appropriate Traffic bylaw will be amended.

### PERMITS/BYLAWS/POLICY

- Dedicated Lands survey to be completed.
- AirBnB operation still under review by Council. None approved at this time.
- Shields to enter into an agreement with the owner of 39 Procter to allow flower beds and fire pit.
- Permit approved for attached garage at 32 Mawson subject to building inspector approval.
- Administrator directed to prepare an amendment to the Council Procedures Bylaw for adoption at the next Council meeting to provide that the Mayor may call a special meeting in the absence of the Administrator. Public Notice will be given.
- Municipalities Act was amended and to operate efficiently, Shields required the following resolutions: 1. Hiring, firing & suspensions will continue to be handled by HR Committee and further that 2. Assessment & Tax rolls will continue to be retained permanently.
- Shed(s) on municipal reserve to be tagged for removal in spring
- Operations staff & administrator to review the insurance policy for additions/deletions.

- Sask Lotteries Grant follow up to be submitted for basketball nets for sport court.
- ICIP-COVID-19 Resilience Stream: An excellent opportunity to apply for funding through ICIP-COVID-19 Resilience Stream for funding (73.33% of cost) for an upgrade to an existing building (the garage by the Sports Court). The proposed upgrade will create a multi-purpose space bringing together a variety of different services to allow space for a food kiosk, bathroom, a separate flex space for community gatherings and storage for equipment. There was urgency around this funding application as Council only had one month to respond and get application and costs together. Councils preferred action for such a project would have been to start with public consultation however, in this case because of the timeliness it was not possible.
