## SUNTERRA SUBDIVISION DEVELOPMENTS

- DAWWU 2019 & 2020 levies and invoice for culvert have been paid
- Amended Agreement has been sent to lawyer for review and comment
- Letter received indicating valuation of improvements & that they are complete has been received and subdivision improvements to be inspected in spring
- Survey of Sunterra residents reviewed and major suggestion is for a shelter belt
- Council approved the subdivision application for 13 lots in the Sunterra Subdivision noting the following:
  - Municipal Reserve allocation likely covered by designated parcel with initial subdivision.
  - Compliant with current Planning Statement Section 3.1 and OCP being developed Section 4.1
  - Drainage for proposed subdivision is in place going forward consideration for parcels north along Sunterra Dr will need to be discussed
