# Resort Village of Shields Monthly Council Highlights Meeting July 20, 2022

#### Services

• The village will be using the services of Taxervice to manage and prepare the documents necessary for tax enforcement within the Resort Village. This service will have no cost to the village as the cost will be charged directly to the property owner.

#### **Development Board**

• The hourly rate for the secretary and members of the Board of Revision and Development Appeals Board was set for the work put into the assessment appeals and development appeals process.

### Permits

- The permits denied were addressed by Council and it was requested to send a letter to the property owner explaining why the permit was denied.
- Trees will be removed on the public reserve lands adjacent to the storage lot, at the residents expense. This will happen in September after the ban on elm tree cutting has passed. The resident will work with the operations manager to ensure that the removal is done to his specifications.
- Water Security Agency approved the berm removal on Munipal Reserve land completed by Rose and John Hill.

#### Insurance

• The Employee Fidelity Bond and Certificate of Insurance from SUMAssure that protect the village against crimes of fraud were presented to council for the 2022 year.

#### AirBnb

• It was noted and will be addressed that there are owners in the village operating Air bnbs without a permit.

### Committees

### Golf Committee

- The Annual Scramble Tournament will be held on August 13<sup>th</sup>. Council approved the liquor permit for the course and also to donate 8 daily pass guestbooks to the golf tournament fund raiser to be used as prizes.
- The Council agreed with the committees recommendation to use a committee member to marshall the course to ensure payment of fees. Council agreed to use only one person rather than all committee members.
- Hole 6 is still being worked on and should be completed next year.
- Junior Lessons were well attended on July 18, 2022
- The Golf Ball fundraiser has started. This fundraiser is to raise money to complete the work required for Hole 6.

### Park/Beaches/Playgrounds

• The beach is getting used more and more by residents. In order to make it more enjoyable, Council agreed to hire HAGS Aquatic to remove weeds from the public beach, with confirmation that they possess the correct permit from WSA, for the cost of up to \$1200.
