### TERMS OF AGREEMENT

1. Course may be booked for a maximum of 2 hours on the week-ends Saturday or Sunday. Course may be booked for a maximum of 4 hours Monday-Friday.
2. A deposit of \$400.00 MUST accompany this document to book the course; this will be credited to your final bill. If the tournament is cancelled within two weeks of the booking date, the deposit will not be refunded, if the booking is cancelled with more than a two-week notice then full refund of the deposit will be granted. In the situation of rain or inclement weather, the course manager and/or the golf committee reserve the right to cancel the event. If a rain check date cannot be rescheduled, a full refund may be available at the discretion of the golf committee. **MAKE CHEQUES OUT TO RESORT VILLAGE OF SHIELDS**
3. An estimate of the number of golfers must be supplied upon booking of the course, and the minimum cost to book the course is \$400.00 (which covers up to 20 golfers), the charge for each additional golfer over 20 golfers is \$20. The remainder must be paid in full on or before the tournament/booking date. \$5.00 fee for power cart trackage unless a member and trackage fees have been paid for the year.
4. Memberships are not valid when booking the course.
5. The tournament draw and any special requests for long drive or closest to the pin competitions must be provided no less than 1 week in advance of the booking.
6. The tournament organization acknowledges and accepts responsibility for any damages to the golf course, golf carts or the hall. The Resort Village of Shields and the Resort Village of Shields Golf Course assumes no responsibility for injury, loss of personal property or any other damages.
7. The Shields Golf Course is a non-licensed facility; permits may be obtained for the Hall and Golf Course and it is the responsibility of the tournament organizers to obtain these permits.
8. Clean up around the hall must be completed immediately after completion of tournament so other golfers can begin play as soon as possible. Course must be left in the same condition as prior to start of tournament. Failure to comply will result in additional fees being applied, hall damage deposit being retained, or loss of privileges for future tournaments.
